- **3.2** B. Morgan noted that Trustees were appointed as a parish councillor representative have no personal interest. B. Morgan also said she will resign from Aylesham District Community Workshop Trust tomorrow.

4. Minutes of Previous Meeting and Matters Arising

- **4.1** Cllr I. Thomas noted a matter arising that he wishes to discuss in a Closed Section of the meeting.
- **4.2** B. Morgan stated in previous minutes she informed resident that developers would probably write as they did for residents in Newman Road.

5. Public Representation Notified to Clerk in Advance of Meeting

- **5.1** Local resident attended a Planning Committee Meeting regarding Cripps Close play area and enquired whether Dover District Council has requested to use a public purchase order to demolish garages currently in the car park. M. Townsend informed resident he would need to contact DDC as this is land owned by them not the Parish Council.
- **5.2** Local Resident enquired whether the amount of planned allotments can increase. B. Morgan noted that it is not the Parish Council who are overseeing them, the Parish Council do not have any land, and the land in question is Dover District Councils. The resident then asked how residents have been informed, it was noted that DDC's Press Officer Nick Evans has advertised a Waiting List (which the PC hold) on several occasions.
- **5.3** Thomas Johnstone Jnr gave an update on the Footpath to Aylesham Cemetery, he has had no reply from the landowner as yet, KCC have advised that this is not compulsory however advised him to contact them. He will therefore send a second open letter with proof of postage to be obtained. Tommy has a meeting with a local accountant in November to discuss options for a group.

17.1 Public Right of Way EE461 - A resident complained regarding trees being planted by developers along Public Right of Way EE461, the trees being planted are dwarf sweet cherry trees around 6ft. The PROW is also not lit properly, residents are using their mobile phones to walk down it, Clerks to raise this with developers.

- **17.2** Street lights in Central Boulevard are being switched off between 20.30 21.00 evening, I. Thomas raised concerns about this.
