# 4. Public representation (notified to Clerk in advance of the meeting)

M.Page (Public representation for item 8 Willow House)

M. Page introduced himself as the property owner. There is currently one holiday let on site and would like to extend that to two. There was previous permission for the conversion of existing barn which has now lapsed and the building is in structural disrepair now. M. Page has been involved with a planning consultant for guidance. They have taken into consideration to the surrounding area, and wants to boost local economy by encouraging use of local facilities. The proposed building is only 2ft higher than existing building as it is being dug into the ground. PROW support the application. The property is next to a conservation area and would like to encourage the natural wildlife.

**Councillor Comments:** M.Townsend raised the question as to how much off road parking there will be. The plan states 8 but there will be more room as there is already existing hard standing on the property.

J.Pout raised query about the water works at the property. M.Page informed the committee that a modern filtration systems will be used, to include a rainwater harvester.

M.Page added that the property's design ensures that access is key. They want to cover every eventuality allowing access to all.

D.Fleck: Noted the high specification and size of the plan, and asked M.Page if he intended to move into the property at a later date. M.Page responded that he has no intention to do this.
