**Incidents of notes.** 

**02/10/22** – Queens Rd, Nuisance bikes, informant reported 2 off road bikes in the area of Queens Rd and the Station Field, this was reported 2 hours after they had left. No descriptions given.

**3/10/22** – Cooting Rd , Theft of pedal cycle from the cycle shelter at Sharpack, a Satan Blue specialised Bike.


**7/10/22** – Co-op Market square, Theft from shop £60-£70 worth of spirits taken. Staffed have named an offender. Crime report is under investigation.

**8/10/22** – Report of a male at an unknown address in Aylesham selling Vapes to underage children. Intel report submitted.

**11/10/22** – Cherry Blossom Waye a male was caught on ring doorbell trying the door handle of a vehicle parked on the drive in the early hours of the morning. Image was circulated for I.D purposes. Police attended area search no trace.

**12/10/22** – Dorman Ave North, Criminal damage of shrubs. This was a dispute, we managed to get the neighbours to mediate and resolve their issues.

**14/10/22** – Adisham Rd Report of a Stag in the road. He is quite famous in the area now and has been seen in various locations.







17/10/22 -999 abandoned call, child on the line. Mistaken call.

17/10/22 - Aylesham Railway Station, Suicide risk.

17/10/22 - 999 abandoned call, child on the line again. Different address.

**17/10/22** -Central Boulevard Informant had bought a vehicle from FB, they felt it was a scam as the vehicle broke down the next day. Advised this was a civil matter.

**17/10/22** -Sellers of the above vehicle call in reporting a dispute on the doorstep over the sale of the vehicle. FB selling sites are sold as seen, all civil. If the money is given in agreement, it can only be disputed in court.

- **20/10/22** Corminster Ave, Nuisance Youths. They were repeatedly kicking the informants door then running away. This was worrying the young children indoors. Police attended, this happed while they were present. Images of the youths have been given to the officers. No more calls. No Damaged caused.
- 20/10/22 Cooting Rd, Abandoned Vehicle. Burnt out van. KFRS attended.
- **23/10/22** Snowdown Colliery 6x off road bikes, all adult males being abusive to the on site security, spraying mud at their vehicle.
- **25/10/22** School SQ, 3 youths trying to gain access to the empty new houses. Police attended area search no trace. Building checked. No damage found.
- **26/10/22** Adisham Rd, RTC Minor injury to hand.
- **27/10/22** Dorman Ave North- Local homeless male jumped infront of a vehicle. He tried the passenger door when the vehicle stopped. This was locked. No damage but the driver was shaken.
- **28/10/22** Cornwallis Ave, Drunk homeless male outside the Londis, sitting in a private doorway, shouting and swearing. Reports the Phone box is being used as a toilet. Will liaise with BT and try to get this removed.
- **29/10/22** Snowdown Court, youths attended the central garden area. They left after a resident knocked on the window to let them know she was watching. This was past midnight, the boys looked very young aged 10-12.
- **30/10/22** Old Court Farm, Poaching. Dogs and vehicle seen on the fields containing crops. No vehicle details.



## **Other News**

Snowdown Court have been having issues with a couple of youths entering the premises, they set off the fire alarm on one occasion. I had a meting with the residents and Housing manager to discuss deterrents etc. The main issue was residents leaving the communal doors open. We requested these be always closed as its very inviting to the younger generation. I have been regularly patrolling this and have had to close the doors!!

A man driving along the Adisham Road unfortunately lost his car due to a fire, he pulled over on Doorman Ave North after seeing smoke in the boot, this immediately burst into flames. It is believed to be the battery that caught alight somehow. The whole car was engulfed in minutes. No body was Hurt.

### **Good News**

On Tuesday 25<sup>th</sup> October Kent Police held a dedicated Ceremony, in recognition of the outstanding work from members of the local community and Kent Police officers with regards to the investigation into the murder of Julia James.

## Finally a good News Story - Rogue Trader Sentenced to Prison

A prolific rogue trader has been jailed after repeatedly targeting elderly residents living in areas including Swale and Medway.

Tony Saunders tricked and coerced several pensioners into paying for unnecessary work to their properties, amid demands for cash payments totalling thousands of

Between February and April 2021, Saunders and an accomplice cold called the homes of victims and warned vital repairs were needed to roofs and chimneys. They wore clothing and used a van emblazoned with logos for 'ATS Paving and Building Ltd'. The business appeared to victims to be legitimate, with quality assurances provided on a leaflet handed to them, including claims of Check-a-trade accreditations.

The reality was very different. Victims were given quotes which rapidly escalated and any work carried out was substandard and often unfinished. In March 2021, a 76-year-old man initially agreed to pay Saunders and his accomplice £7,000 for roof repairs to his Faversham home. After work commenced, he was met with demands for £25,000. The victim became suspicious and challenged the men, following which Saunders threatened to empty a skip onto his driveway and remove all materials if he wasn't paid. In the following month, Kent Police was called to reports Saunders was operating fraudulently in Istead Rise, Gravesend, where two elderly neighbours, both aged in their 80s, had been scammed. Saunders, aged 23, of Spade Lane, Hartlip was arrested at one of their addresses on 7 April, which also led to a Citroen Berlingo van being seized.

### Further offences -

An investigation established he had also been operating in areas of Chatham, Sittingbourne and New Romney. Saunders was also investigated for a separate case in 2019, when an unknown suspect knocked at the door of an elderly woman in Chatham and claimed to be from Trading Standards. The person had knowledge the woman was a previous victim to rogue trading and informed her the perpetrators had been arrested and that she was now entitled to compensation. The victim, aged in her 80s, was later contacted by telephone and told before she received the compensation, she would first need to pay for court fees and staff.

Between 4 and 16 April 2019, she made nine withdrawals from her bank account, totalling almost £30,000. Saunders stopped her on multiple occasions whilst she was driving home from the bank, in order to take the cash from her. Saunders pleaded guilty at Maidstone Crown Court to six counts of fraud by false representation with a further two counts taken into consideration, and four counts linked to money

laundering. He also admitted a further, unrelated, charge of affray. This was linked to his involvement in a fight in Herne Bay, in July 2020. On Friday 25 February 2022, Saunders was sentenced to four years and ten months' imprisonment.

### Preyed upon vulnerable

Detective Sergeant Adam Stallard, of the Kent and Essex Serious Crime Directorate, said: 'Saunders preyed upon the elderly and vulnerable under the guise of operating a legitimate business. He invented or exaggerated fears related to the integrity and safety of victims' roofs and chimneys, often demanding instant cash payments for so called urgent repairs.'Site surveys were later completed by a genuine chartered surveyor at the home addresses of victims. All of these surveys found that the works were mostly unnecessary, were to an extremely poor standard and were substantially overpriced.'It is pleasing to see that justice has caught up with Saunders and he is rightly behind bars. We will now use legislation contained under the Proceeds of Crime Act to ensure he doesn't continue to benefit from his crimes when he is released from prison.'
