New Local Plan Update -

As Aylesham Parish Council are aware the Local Plan is behind schedule. A new improvement scheme has been proposed for the Whitfield roundabout, DDC are working with National Highways and Natural England with this being the main focus. The Chair and Vice Chair of DDC Planning Committee and District Councillors have written to Ashley Taylor at DDC to say that unless arrangements include the duelling of the A2 they will object.

The housing target is 611 homes per year.

Regulation 19 will now go to cabinet in October, and then will go out to consultation. There will be Local Plan meetings held before then.

The Local Plan will not be adopted until at least 2023.
