7.4 Snowdown Colliery Welfare Male Choir

Outline: They are launching a project called Men United in Song. The object of this project is to try to attract men to get involved in a free course of singing which will last 8 to 10 weeks culminating in a Gala Concert to be held at the Nye Hall, Duke of Yorks School on 16th July 2022. Participants will be expected to raise sponsorship in support of Prostate Cancer UK which is a charity close to their hearts. Ultimately, they hope that they may want to continue singing by joining the choir. This will not only benefit them socially and therapeutically but will further the community spirit within Aylesham and surrounding areas.

Amount Requested: £1,000 to help with the additional costs for our professional musicians as this project is in addition to our normal activities. All of these professionals are employed under contract and are not related to any choir members. The total cost of employing them for this project is estimated at £2,750.

Last grant approved by Council: Not applicable – this is the first application to the Council.

Resolved: To approve the grant for the full amount of £1,000.
